Notice is hereby given that the National Company Law Tribunal has ordered the commencement of a corporate insolvency resolution process against Aircel Limited on March 12, 2018.

- Form C- for Claims by Financial Creditors
- Form D- for Claims by Workmen and Employees
- Form E - for Claims by Authorized Representative of Workmen & Employees
- Form F - for Claims by Creditors (Other than Financial Creditors and Operational Creditors)
